### Payments & Terms

Open Account - On approved credit, payment terms of net 30 days will be granted. Invoices not paid within 30 days may be subject to interest of 1.5% per month until paid.

Credit Card - American Express, Master Card, or VISA.

### Pricing

All prices are subject to change without notice. Written quotations are good for 30 days unless otherwise noted. Changes in quoted quantities at time of delivery may result in a change in price.

### Minimum Orders / Delivery

Orders placed with the corporate branch (16001 Trade Zone Ave.) that are less than \$300.00 will be subjected to a \$20.00 service charge. Orders placed at any of our branches or ProCenter locations must also meet a minimum of \$300.00 or a \$20.00 service charge will apply. All orders for customers outside our normal delivery area will be serviced by common carrier or parcel service and may be subjected to a service charge based on the order size. All deliveries are subject to government regulations.

### Returns

Stocking items may be returned only with written authorization and if the product is in original packaging in resalable condition. Special Order items are not returnable. Delivery and sales associates are not authorized to accept returns without prior written authorization from Daycon. Credit will not be issued without a signed credit return.

### Claims for Damaged Goods

Claims for goods damaged by a common carrier or parcel service are to be submitted to the appropriate carrier.
