Description:

Gone II is a highly effective, general purpose carpet spotter with encapsulating chemistry to control odors, prevent re-soiling, and brighten carpets. Gone II is approved for use on carpets by the Carpet and Rug Institute and meets the requirements for certification by Underwriters Laboratory Environmental (ULE) standard UL 2795. Gone II encapsulates dirt, and then dries it to hard crystals, which can be easily and more efficiently vacuumed up. Gone II leaves a protective barrier on carpet fibers to keep the carpet clean for a longer period of time. Its non-alkaline formula is particularly effective on stains consisting of proteins, starches, fats, ink, or grease. Gone II will not harm the carpet backing, pads, or cause brown out. Gone II's encapsulating properties help keep the carpet looking clean longer. It is truly a versatile and effective general purpose spotter.

Directions:

Spray stain lightly and blot with a clean, white rag. Repeat if necessary. Safe to use on all commercial carpeting and most residential carpeting. TEST FOR COLOR FASTNESS ON IMPORTED WOOL, COTTON AND ORIENTAL CARPETS.

Product Disposal:

Dispose of in accordance with local, state, and federal regulations. It is recommended that the high density polyethylene container and any corrugated packaging be recycled.
